The Project Clearinghouse is the central location on the Oregon Community Solar Program website where prospective Participants can compare community solar projects and begin the process of requesting information from different Project Managers at portal.oregoncsp.org/p/ProjectFinder.

When a Project Manager applies for Pre-certification, they agree to allow the Program to post the following project level information on the website. Project Managers must also indicate at least one residential subscription pricing product that will be listed publicly on the website. It is optional to provide public information for additional pricing products.

Project and subscription information submitted at Pre-Certification will automatically populate the information displayed on the website. The italicized text below is for illustrative purposes only.
